### **DELHI GOVERNMENT SHOULD REDUCE VAT ON CNG, PETROL & DIESEL**

LOK SATTA PARTY HOPES DELHI GOVERNMENT WILL CONSIDER REDUCING VAT ON PETROL AND DIESEL ON THE LINES OF GOA WHERE THE PRICE OF PETROL HAS BEEN REDUCED BY RS 11.
